There will be a production server owning the P-VOLS and another server running the backups. You decide to run the horcm instances 0 and 1 on both servers for backup purposes. After the first paircreate you discover that your production data has been destroyed because data was copied from the secondary volume to the primary volume. Why did this happen?

- A. The production server was down during paircreate.
- B. HORCMINST was set to 1 and you defined the -vl option on paircreate.
- C. You defined the -vr option on paircreate and HORCMINST was set to 1.
- D. You did not define the -vl option when issuing the paircreate command.
