### QUESTION 1

A customer is performing a upgrade to IBM FileNet P8 V5.1. They have three environments, DEV (V4.0), Test (V3.5) and PROD (V3.5). After completing the Test system upgrade, the customer is finding many PE work objects in the exception state. Before running the upgrade again, what steps need to be taken in order to correct the issue?

- A. Restore the databases and reassign work objects as required.
- B. This is a test system and many users are created by testers, so this is not a problem.
- C. Restore the IBM FileNet Process Engine 3.5 software and reassign work objects as required.
- D. Restore the databases and the IBM FileNet Process Engine 3.5 software, then reassign work objects as required.

### QUESTION 2

A customer is building multiple stand-alone development servers with IBM FileNet P8 V5.1, but is concerned with the amount of time required to perform all the prerequisites and configuration for each server. They are seeking input from the consultant to reduce the workload implementing this requirement. What would be the best recommendation?

- A. Install the core engines and all middleware on each server using the Composite Platform Installation Tool.
- B. Help them complete the Installation and Upgrade Worksheet for the first server, and install the core engines and all middleware using information in the worksheet to configure the Composite Platform Installation Tool. Copy the installed directories to the remaining servers.
- C. Help them complete the Installation and Upgrade Worksheet for the first server, install the core engines using the information in the worksheet and the silent install scripts on the first server. Copy the software directories to the others servers and install using the silent install scripts.
- D. Help them complete the Installation and Upgrade Worksheet for the first server, install the core engines using the information in the worksheet and the standard installation. Then, copy the worksheet and replace the server names for the remaining servers and perform the installation on each server.

### QUESTION 3

A customer is upgrading and merging two IBM FileNet P8 domains into a single new IBM FileNet P8 V5.1 domain. One source domain is at IBM FileNet P8 V3.5.2, the other is at IBM FileNet P8 V4.5.1. Both source domains use the same LDAP. What order, if necessary, needs to be followed when upgrading and adding the source domains into the new unified domain?

- A. There is no order precedence.
- B. You must add the P8 V3.5.2 source domain first.
- C. You must add the P8 V4.5.1 source domain first.
- D. You cannot merge P8 3.5.2 and P8 4.5.1 source domains together while upgrading.

#### QUESTION 5

After an upgrade to IBM FileNet P8 V5.1 of a Highly Available BPM installation with Content Engine (CE) in an IBM WebSphere cluster, the administrator discovers an issue with CE. Working with an IBM support representative it is determined that an interim fix for CE needs to be applied. The fix pack EAR file is copied to the CE lib directory and the current EAR file is undeployed. Then the Configuration Manager was used to update the bootstrap information and deploy the application to the Deployment Manager. During testing, the administrator was unable to logon onto the PE. Which next steps should be taken to resolve this issue?

- A. Redo the MustGather information, escalate the issue with IBM Support.

- B. Use the IBM FileNet P8 V5.X Fix Pack Compatibility Matrix to determine which fix packs are compatible.
