QUESTION 1

Case Study 1 - ADatum

Overview

ADatum Corporation develops a software as a service (SaaS) application named E-invoicing.

Existing Environment

Application Architecture

E-invoicing consists of a single-page application (SPA) and a backend web service that provides invoice management and processing functionality.

E-invoicing stores all the details of each invoicing operation in a backend cloud database. E-invoicing generates invoices in PDF format and provides users with the ability to download the PDF after it is generated. Each invoice has a unique identifier named invoiceid.

The users have a common workflow where they sign in to E-invoicing, and then open E-invoicing in multiple tabs of a web browser so they can use different parts of the application simultaneously.

Security Architecture

ADatum uses the principle of least privilege whenever possible. ADatum always uses the latest libraries and integration endpoints.

Requirements

Business Goals

ADatum wants to integrate E-invoicing, Azure Active Directory (Azure AD), and Microsoft Graph so that their customers can leverage Microsoft Office 365 services directly from within E-invoicing.

You need to configure the initial login request in the access token JavaScript script.

QUESTION 2

Case Study 2 - Contoso

Existing Environment

Microsoft 365

Contoso identifies the following business goals:

- * Utilize core functionality of apps whenever possible.
- * Reduce app development costs.
- * Minimize training costs for end users.

Microsoft SharePoint/Microsoft Exchange

Contoso has a Microsoft 365 subscription that uses a domain named contoso.com. Each user is assigned a Microsoft 365 Enterprise E5 licence.

Problem Statement

Contoso moves all email accounts to Microsoft 365.

Contoso migrates the SharePoint Server 2013 intranet sites of the research department to SharePoint Online.

Requirements

Business Goals

Contoso identifies the following issues:

- * Users in the sales department report that preparing quotations is time-consuming as it requires manually copying and pasting data from multiple sources.
- * Users in the HR department must use multiple apps to manage the hiring process.
- * The solution to claim expenses requires multiple manual steps.

Planned Changes

Contoso identifies the following business goals:

- * Utilize core functionality of apps whenever possible.
- * Reduce app development costs.
- * Minimize training costs for end users.

Technical Requirements

Contoso plans to implement the following changes;

- * Redesign the SharePoint Online sites of the research department to provide users with an experience that is consistent with the Microsoft 365 portal. The research department has a third-party project management solution that uses the Microsoft identity platform in Azure AD.
- * Create an email workflow solution for expense claims. Users will submit their expense claims and the system will email an approval request to their manager.
- * Implement a bring your own device (BYOD) model that supports Windows 10, macOS, and Android devices.
- * Develop a custom Microsoft 365 app named SalesApp for the sales department.
- * Develop a custom Microsoft 365 app named HRApp for the HR department

You need to provide users with access to SalesApp. The solution must meet the technical requirements. What should you include in the solution?

- A. App Catalog in SharePoint Online
- B. sideloading
- C. Centralized Deployment
- D. Microsoft AppSource

Answer: A

Explanation:

An app catalog is a dedicated site collection in a SharePoint web application or SharePoint Online tenancy that hosts document libraries for Office and SharePoint Add-ins. To make Office Add-ins accessible to users within their organization, administrators can upload Office Add-ins

manifest files to the app catalog for their organization. When an administrator registers an app catalog as a trusted catalog, users can insert the add-in from the insertion UI in an Office client application.

Scenario:

SalesApp must be integrated with Microsoft Word and must combine images and text from multiple sources to create a quotation as a DOCX file.

The distribution of SalesApp must be automatic and require minimal user interaction.

You are developing a new application named App1 that uses the Microsoft identity platform to authenticate to Azure Active Directory (Azure AD).

Currently, App1 can read user profile information.

You need to allow App1 to read the user's calendar.

Solution: Add <https://graph.windows.net/user.read> to the list of scopes during the initial login request.

Does this meet the goal?

- A. Yes
- B. No

Answer: B

Explanation:

Microsoft Graph Calendars.Read allows the app to read events in user calendars.

For your app to access data in Microsoft Graph, the user or administrator must grant it the correct permissions via a consent process.

Application permissions are used by apps that run without a signed-in user present; for example, apps that run as background services or daemons. Application permissions can only be consented by an administrator.

QUESTION 4

You plan to deploy a SharePoint Framework (SPFx) solution to the tenant app catalog.

QUESTION 5

You are developing a Microsoft Teams application for a support staff.

Within a conversation between the support staff, you want the staff to look up support ticket IDs from a list without opening the ticketing system.

Which feature should the application include?

Answer: C

Explanation:

Messaging extensions allow users to interact with your web service through buttons and forms in the Microsoft Teams client. They can search, or initiate actions, in an external system from the compose message area, the command box, or directly from a message. You can then send the results of that interaction back to the Microsoft Teams client, typically in the form of a richly formatted card.

QUESTION 6

For the event, group event, group post, message, personal contact, task, task list resource types, you can use the same REST request as getting the resource instance, look for an extension that matches a filter on its id property, and expand the instance with the extension. The response includes most of the resource properties.

Example: GET /users/{Id|userPrincipalName}/events/{Id}/extensions/{extensionId}

QUESTION 8

You have an application named App1 that is used to administer an Azure Active Directory (Azure AD) tenant.

their mailbox but can't consent to allow an app unfettered access to read and write to all files in your organization.

QUESTION 9

You are developing a SharePoint Framework (SPFx) web part. The web part will call a backed API that is secured by using Azure Active Directory (Azure AD). The web part will be on a page that has many other web parts.

Which type of web part should you use ensure that access to the exclusive to the web part?

Answer: C

Explanation:

When added to the page, isolated web parts are displayed using an iframe. This iframe points to a unique domain assigned to the SharePoint Framework solution where the web part is located. This domain is also referenced in the return URL of the Azure AD application created to host the isolated permissions for the particular SharePoint Framework solution. Using the unique domain allows to ensure, that only web parts from the particular SharePoint Framework solution can obtain an access token for the isolated set of permissions.

QUESTION 10

You are building a Microsoft Office Add-in for Outlook that will use the Microsoft Graph REST API to retrieve a user's documents from a Microsoft SharePoint Online site.

What should the add-in provide to retrieve the documents on behalf of the user?

- A. an identity token
- B. a single sign-on (SSO) token
- C. a refresh token
- D. an access token

Answer: D

Explanation:

Get an access token.

Note: The Outlook REST APIs require a bearer token in the Authorization header. Typically, apps use OAuth2 flows to retrieve a token. However, add-ins can retrieve a token without implementing OAuth2 by using the new `Office.context.mailbox.getCallbackTokenAsync` method introduced in the Mailbox requirement set 1.5.

After your add-in has the access token, item ID, and REST API URL, it can either pass that information to a back-end service which calls the REST API, or it can call it directly using AJAX.

QUESTION 11

You develop a Teams app that has a task module to display an Adaptive card that can be used to collect customer information.

You need to have the task module invoked in Teams. The effort to accomplish this should be kept to a minimum.

Explanation:

Task modules can be invoked from a deep link outside Teams, bots, and personal tabs.

Task modules should be used to provide a model popup experience in Teams applications. You can show a widget such as Vimeo or Streams, custom JavaScript/HTML code, or display an adaptive card.

You can create a deep link for most entities within Teams. Deep links may be useful when navigating the user to content within one of your app's tabs.

Task modules can be invoked from Microsoft Teams bots using buttons on Adaptive cards and Bot Framework cards.

Task modules can be invoked from a Teams tab using `microsoftTeams.tasks.startTask()` passing a `TaskInfo` object and an optional `submitHandler` callback function.

Task modules cannot be invoked from a messaging extension. Messaging extensions allow users to interact with your web service through buttons and forms in the Microsoft Teams client.

Task modules cannot be invoked from a webhook. Webhooks are used to post data to or from Teams to any chosen service capable of accepting a JSON payload.

QUESTION 12

You have a SharePoint Framework (SPFx) web part named WebPartA that uses SPFx 1.11.0.

You need to ensure that WebPartA can be installed as an app in Microsoft Teams.

What should you do?

- A. Update the WebPartA.manifest.json file.
- B. Update the Config.json file.

You plan to display 30 emails per page. The most recent emails must be displayed first.

Explanation:

Box 1: skip

With skip=60 you skip the first two pages and you get the third page.

Box 2: top

In order to get 30 mails per page you must use top=30.

Incorrect Answers:

\$select

To specify a different set of properties to return than the default set provided by the Graph, use the \$select query option. The \$select option allows for choosing a subset or superset of the default set returned. For example, when retrieving your messages, you might want to select that only the from and subject properties of messages are returned.

\$search

To restrict the results of a request that match a search criterion, use the \$search query parameter. You cannot use \$filter or \$orderby in a \$search request.

initialRun - A Boolean value indicates whether the command runs initially with no parameters. Default is false.

Note: The Microsoft Teams app manifest describes how your app integrates into the Microsoft Teams product.

Step 3: Add composeExtensions to the app manifest.

composeExtensions - Optional array. Defines a message extension for the app.

composeExtensions.commands

Your message extension must declare one or more commands with a maximum of 10 commands. Each command appears in Microsoft Teams as a potential interaction from the UI-based entry point.

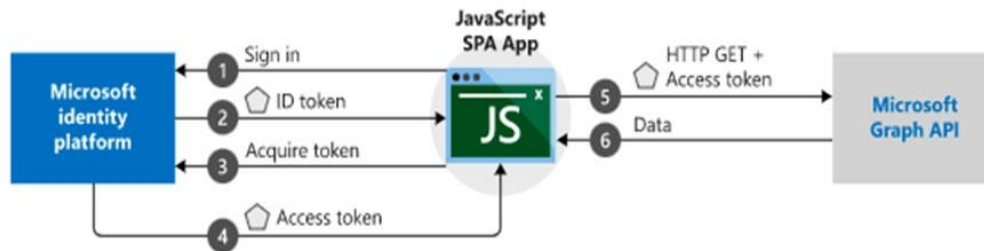
